Background

Resolution CIML/2022/05 was approved by the CIML at its 57th meeting. The resolution concerns issuing a request for candidacies for a CIML First Vice-President and a CIML Second Vice-President to replace the incumbents when their terms conclude.

Nomination for election as Second Vice-President of the CIML

Dear Colleagues,

I hereby formally submit my nomination for election as Second Vice-President (VP) of the CIML.

My motivation for election to this position is as follows:

- To have the opportunity to more effectively support the international legal metrology community benefit from technical and regulatory innovations being implemented through the 4 pillars of the work program of the International Organization of Legal Metrology (OIML), i.e. OIML Recommendations, activities in support of Countries and Economies with Emerging Metrology Systems (CEEMS), the OIML Certification System (CS) and the Digital Taskforce; and
- To support the CIML President, First Vice-President and BIML Director to develop and implement a long-term strategy for the ongoing success of the OIML.

I have outlined below my roles and responsibilities in support of my nomination and, in doing so, wish to highlight my many years of experience encompassing both technical and management roles across the public and private sector (curriculum vitae attached below). Throughout my career, I have always identified and embraced opportunities to work across a range of industry sectors in different capacities, as these experiences have given me a unique professional perspective as well as a broad variety of skills and knowledge to draw upon.

- **Nearly a decade of engagement with and support for the work of OIML:**

I joined the National Measurement Institute Australia (NMIA) in 2015 and was formally appointed as Australia's representative to the CIML and the Asia Pacific Legal Metrology Forum in 2016. From the start, I have appreciated the immense value and importance of legal metrology and the role of OIML in supporting the work of its Members, in reducing technical barriers to trade, and in ensuring the effectiveness and harmonisation of systems and frameworks in areas such as environmental protection and health and safety regimes.

- **Leadership in international legal metrology:**

Within the OIML I currently serve as Deputy Chairperson of the Management Committee for the OIML-CS (a role I will relinquish at the end of 2023). In this role I have made significant contributions to support the implementation and ongoing improvement of the OIML-CS. I am also a member of the CEEMS Advisory Group and the OIML Digital Taskforce as I believe the future of legal metrology will depend upon building the capabilities and contributions of *all* OIML members as well as on the successful incorporation of emerging technologies into OIML's scope of work.

In 2018, I was invited to join the CIML Presidential Council to assist the President and Presidential Council develop and implement plans for a long-term strategy for OIML. I was elected to the Executive Council of the Asia Pacific Legal Metrology Forum in 2021. It is a privilege to serve in both of these roles and I am delighted to continue to contribute in these capacities.

My aspirations if elected as Second Vice President include the following:

- Ensuring that OIML becomes a more dynamic and responsive organisation to, e.g, maintain and enhance its relevance, support its members and keep pace with the increasing acceleration of innovation and technology in industry. As 2nd VP I would continue to work with all CIML Members, the Presidential Council and Regional Legal Metrology Organizations to develop more efficient mechanisms to maintain the currency and relevance of OIML Recommendations and embrace the digital age. It is vital that we adapt to and leverage the technological advances characterised as the 4th Industrial Revolution. OIML has an important role to play in the digital transformation of legal metrology systems. As 2nd VP I will facilitate an internationally harmonised approach across the quality infrastructure, in particular working with colleagues in the scientific metrology community through the International Committee for Weights and Measures (CIPM), to truly take advantage of developments and innovations in this space.
- Empowering and investing in the knowledge, skills and capabilities of all OIML members noting that the strength of OIML lies in its membership and the breadth of knowledge and experience it can draw upon to solve complex problems and provide meaningful outcomes. By strengthening the contributions from our members, we strengthen OIML as a whole and improve the international legal metrology system for the benefit of all. I would seek to increase practical support for CEEMS through skills and knowledge transfer as well as multilateral and regional programs in areas such as market surveillance, digitisation, and Conformity to Type.

I believe OIML has made great progress in addressing these and other critical issues, however I am also conscious that more work is required. I look forward to supporting these future efforts in whatever capacity CIML decides. If elected, I will support the CIML President and First Vice-President and deploy my skills and experience to position OIML for future success.
